Access to the investor portal (the “**Portal**”) and the information contained in the Portal or other written or multimedia information contained either on this website, or access to which is provided on or through this website (the “**Information**”) is being made available to a limited number of investors in VANDERBEURZE FUND (the “**Fund**”) on a confidential basis by VANDERBEURZE MANAGEMENT SARL (“**VANDERBEURZE**”) and any duly authorised agent of VANDERBEURZE or its associates in respect of the Fund, for the purposes of providing certain information about the Fund, VANDERBEURZE and its associates.

Any references herein to a “person” includes any government, state, state agency, body corporate, unincorporated association, partnership, trust, any other type of entity and any natural person.

The Portal and the Information is proprietary to VANDERBEURZE and all content is subject to copyright with all rights reserved. Certain of the Information contains non-public, proprietary, commercially sensitive and highly confidential information. By clicking “Agree” below or accepting delivery of or viewing all or any part of the Information, the recipient (and any person he or she represents) accepts the terms of this notice (the “**Notice**”) and agrees:
